MEMORANDUM FOR RECORD

SUBJECT: 2018-2019 Dove Hunting on Fort Campbell

1. This memorandum contains specialized regulations pertaining to Dove Hunting on Fort Campbell for the 2018-2019 Dove Hunting Season. These guidelines, in addition to all regulations in CAM Regulation 200-4, apply to all dove hunters participating in opening day activities and subsequent dove hunts on Fort Campbell.

a. Hunters are authorized to hunt dove in any area designated for Small Game Hunting in Fort Campbell's iSportsman Portal within season constraints described below.

b. Season dates are: 1 September (beginning at noon) – 28 September 2018, 13 October – 4 November 2018, and 8 December 2018 – 15 January 2019.

c. Hunters must check-in to areas through the Fort Campbell iSportsman Portal and obtain appropriate area assignment(s) prior to entering any area.

d. Hunters must check-out immediately following their hunt.

e. Hunters must possess a Tennessee OR Kentucky State hunting license, migratory bird permit, and a Fort Campbell permit authorizing dove hunting (small game permit or sportsman permit).

f. Special hunts will occur on 1 September at designated fields prepared specifically for dove hunting opportunity. Hunt descriptions, special details, and map of fields can be found in this memorandum on following pages.

2. 1 September 2018 Dove Hunt – TA21 Dove Field.

a. Field is planted in 6 acres of sunflowers, 5 acres of millet, and 3 acres of winter wheat.

b. Hunters must check-in through iSportsman at 19:00 (7:00PM) on Friday 31 August. There will be a maximum of 18 check-ins allowed through iSportsman. 2 locations will be available for handicapped hunters. Handicapped hunters must come to Bldg. 6645 to receive an area assignment on Thursday 30 August between 0730-1600. Only 2 handicapped hunting locations will be available for TA21 Dove Field.

c. All hunters are authorized to bring 1 hunting companion. Companion's full name and Fort Campbell permit number must be written on the hunter's area assignment. Companions must also possess a copy of the area assignment while hunting. If two vehicles are driven to field, hunters and their companions must both display an area assignment in their vehicle dashboard in a manner visible to law enforcement and other officials.

d. Hunters must hunt within 10 meters of a flagged location at all times unless retrieving a downed bird. Hunters are prohibited from firing their weapons any distance further than 10 meters from flagged location. Altering positions of flagged locations will result in immediate removal from the field. Hunters are allowed to switch locations if another location becomes unoccupied.

e. Hunters are authorized to enter the field at 11:00 to select their desired flagged hunting location. Shooting time is noon (12:00). Shooting prior to noon will result in removal from field, suspension of hunting privileges and potential enforcement action.

f. Spinning-winged decoys are PROHIBITED on 1 September. Spinning-winged decoys are authorized for use on subsequent hunts following opening day.

g. Shooting at "low birds" is PROHIBITED. Shooting at a low bird that potentially puts another hunter at risk will result in immediate removal from field, suspension of hunting privileges, and potential enforcement action.

h. All other regulations regarding hunter harassment and hunting methods mentioned in CAM Regulation 200-4 apply.

3. 1 September 2018 Dove Hunt – Lake Kyle Dove Field.

a. Field is planted in 3.5 acres of sunflowers, 7 acres of millet, and 1 acre of winter wheat.

b. Hunters must check-in through iSportsman at 19:00 (7:00PM) on Friday 31 August. There will be a maximum of 18 check-ins allowed through iSportsman. 2 locations will be available for handicapped hunters. Handicapped hunters must come to Bldg. 6645 to receive an area assignment on Thursday 30 August between 0730-1600. Only 2 handicapped hunting locations will be available for Lake Kyle Dove Field.

c. All hunters are authorized to bring 1 hunting companion. Companion's full name and Fort Campbell permit number must be written on the hunter's area assignment. Companions must also possess a copy of the area assignment while hunting. If two vehicles are driven to field, hunters and their companions must both display an area assignment in their vehicle dashboard in a manner visible to law enforcement and other officials.

d. Hunters must hunt within 10 meters of a flagged location at all times unless retrieving a downed bird. Hunters are prohibited from firing their weapons any distance further than 10 meters from flagged location. Altering positions of flagged locations will result in immediate removal from the field. Hunters are allowed to switch locations if another location becomes unoccupied.

e. Hunters are authorized to enter the field at 11:00 to select their desired flagged hunting location. Shooting time is noon (12:00). Shooting prior to noon will result in removal from field, suspension of hunting privileges and potential enforcement action.


f. Spinning-winged decoys are PROHIBITED on 1 September. Spinning-winged decoys are authorized for use on subsequent hunts following opening day.
